



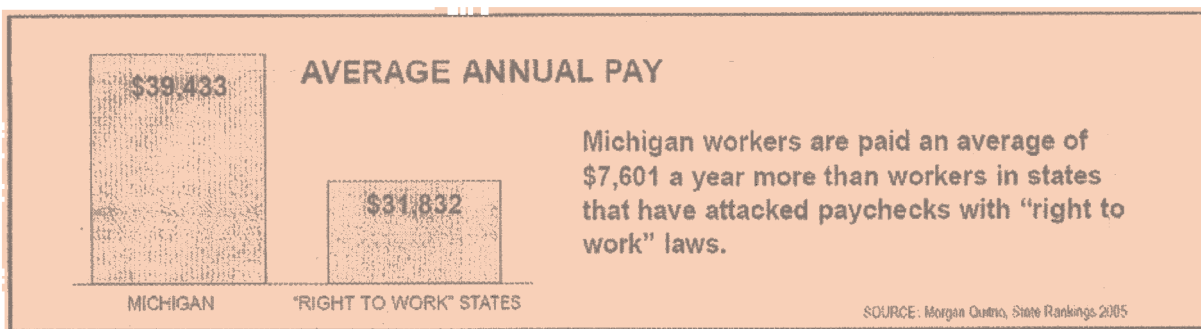
Stop Right-to-Work in Michigan!
